



Terms and Conditions of Application

A reminder of the Terms and Conditions...

- I understand that to submit an application I must be aged over 18.
- I understand that to submit an application my legal gender must be female.
- I understand that to submit an application I must be a size UK14 / US10 or above, and that if at any time whilst representing Miss Voluptuous Pageants as a finalist or titleholder I am not a size UK14 / US10 or above, I will no longer be eligible to compete or hold title.
- I understand that submitting an application does not guarantee acceptance, nor does it automatically enable me to compete in Miss Voluptuous Pageants. I understand that Miss Voluptuous Pageants reserve the right to reject applications based on suitability for the system.
- I understand that should I be selected as a finalist, I will be required to provide photographic ID and proof of residence.
- I understand that if selected as a finalist, there is a Sponsorship fee payable of £220 and that this can be paid in instalments. I also understand that to secure my place in the competition, I will be required to pay a deposit.
- I understand that no '14 day Cooling-off Period' is applicable as per Section 28 (h) of The Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013.
- I understand that competition divisions are subject to change based on minimum participation numbers. I also understand that competition dates and locations may also be subject to change at any time, and in such a case, I am not eligible for a refund should I be unable to attend.
- I understand that if I am unable to fulfil my obligation as a delegate for any reason, fees paid are forfeited and held with the Miss Voluptuous Pageants and cannot carry over under any circumstances. Entry fees are credited for the current pageant year only. Miss Voluptuous Pageant system will not be required to refund any amount of the fees nor will I be able to continue to wear my sash if such items have been issued.
- I understand that all fees paid to Miss Voluptuous Pageants are not refundable and not transferable in full or in part under any circumstances. This includes, but is not limited to entry fees, advertising fees, event ticket sales fees, and any other fees paid to Miss Voluptuous Pageants by anyone including, but not limited to, delegates, sponsors, and advertisers.

- I understand that there are strict deadlines for payments and that missed payment dates may result in spaces being forfeited. I understand that I must adhere to all deadlines for photographs, payments and contestant information requested by Miss Voluptuous Pageants, including but not limited to information requested by partners, sponsors and associates.
- I understand that prizes and other benefits may be subject to change / withdrawal at any time without prior notice. I understand that prizes given by sponsors to prize winners are not the responsibility of Miss Voluptuous Pageants and Miss Voluptuous Pageants cannot be held liable for any sponsor not fulfilling their prizes to winners.
- I understand that terms and conditions may be subject to change at any time without notice.
- I understand that any information or photographs I submit to the pageant, including on my application may, in whole or in part, be used for advertising purposes. I understand that in order to opt out of having my full name shared, I must inform the team of an alias I wish to use.
- I understand that if I am selected as to represent my country that I may not compete in any other pageants, beauty contests or modelling competitions.
- I understand that to be eligible to compete for a title outside of my home country, (ie living in Ireland and also competing for Wales) the following conditions must be met;
 - Place of representation may be birthplace, place of residence or place of work or study
 - Heritage Claim - Place of representation may be the birth place of a parent or grandparent
- I understand that I must look solely to Miss Voluptuous Pageants with respect to all matters relating to participation including but not limited to; application, rules, regulations, policies, preparation, rehearsal, performance and selection process, and all other matters relating to the pageant and holding title.
- I understand that Miss Voluptuous Pageants, its sponsors, associates and pageant personnel are not responsible for accidents, injury or theft incurred at the time of Miss Voluptuous Pageants finals and events, or during travel to and from Miss Voluptuous Pageants finals and events.
- I understand that Miss Voluptuous Pageants is not responsible or liable for any negligence or fraud committed by pageant sponsors, judges, or contract vendors who may be providing products or services to delegates and winners at the National or International Final.
- I understand that Miss Voluptuous Pageants is not responsible or liable for negligence or fraud committed by any host accommodation providers.
- I understand that Miss Voluptuous Pageants is not responsible or liable for loss, theft, or damage caused to any and all prizes, gifts, and awards bestowed upon me after these items become my property. I agree to incur replacement and/or repair costs to lost, stolen, or damaged items including but not limited to: crown, sash, trophies, crown case, banner bag or other gifts or prizes.

Conduct Requirements

- I understand that by applying, I am confirming that I am a person whose background is not likely to bring the Miss Voluptuous Pageants system or any person associated with them, into disrepute.
- I understand that my application affirms that I am and will continue to be a person of good moral character; that I have not committed and will not commit any act inconsistent with the values of a role model or that will reflect unfavourably on the pageant, its representatives, sponsors and/or associates.
- I understand that my application affirms that I will conduct myself in a courteous, professional manner at all times during the Miss Voluptuous Pageants Final and while representing the system, sponsors, associates or any other third parties involved.
- I will not slander or libel other contestants, judges, Miss Voluptuous Pageants staff or anyone else involved with or connected to Miss Voluptuous Pageants. Defamatory verbal and/or written remarks against Miss Voluptuous Pageants will result in immediate disqualification, forfeiture of any and all issued prizes and awards, and legal action, including but not limited to financial penalty charges. I understand that any delegate found publicly posting slanderous remarks on public forums, social networking sites or any other public domain will be immediately disqualified and will be ineligible to reapply at any time.
- I understand that Miss Voluptuous Pageants has a zero tolerance policy on bullying and I agree that should I be accepted I will behave in a manner that is respectful to my fellow contestants and team members.
- I understand that good sportsmanship is expected at all times. Disruptive behaviour before, during, or after the pageant may result in disqualification, forfeiture of any and all issued prizes and awards, removal from the premises, and legal action, including but not limited to financial penalty charges.
